Welcome and introductions – Dr. Cardin welcomed everyone and thanked them for attending our Zoom SSC meeting. Everyone introduced themselves. Mr. Modesti recorded the meeting after gaining permission from attendees.

Approval of previous SSC meeting minutes from 2/13/2020: Members reviewed the minutes from previous meeting. Brooke Wunschel made a motion to approve as written, Emily Bohl seconded, all were in favor, approved (8 yeas, 0 nays).

School Site Council Training – Dr. Cardin facilitated the annual SSC training with members, covering roles and responsibilities. Slide Show presentation attached.

Mr. Modesti shared the differences in the various evacuation scenario procedures. Rebecca White made a motion to approve the CSSP as written, Emily Bohl seconded, all were in favor, approved (8 yeas, 0 nays)

2020-21 Single Plan for Student Achievement (SPSA) Review
